**Annual Member**

Contributions of \$50.00 - \$999.00 to the Foundation within the previous twelve months

**Sustaining Member**

Contributions of \$1,000 - \$2,499 to the Foundation or undertaking to contribute \$250.00 per year to the Foundation for 5 years

**Lifetime Member**

Contributions of \$2,500 - \$4,999 to the Foundation or undertaking to contribute \$500.00 per year to the Foundation for 5 years
